Dirge Sounds For Fullerton Musical Instrument Company

FULLERTON - Instruments through which the music of a halfcentury marched and rippled may still sound out somewhere but the equipment which manufactured them was being hauled away today from F.E. Olds & Son Co. in Fuller-

The men who created those instruments are gone too, - gone to other jobs with the closing of the Fullerton plant at 350 N. Raymond Ave., working at or looking for other

The lone employee on duty this morning was the plant's general manager, Don Agard, who is being assisted by a corps of part-time aldes, many of them former employees at the Olds plant.

At a marathon 11-hour auction, machinery and auxiliary equipment were sold Wednesday and will be moved out by the new owners during the next two weeks. The auction was attended by some 500 bidders and visitors at the start of proceedings. The number fluctuated during the long auction day.

Signaling the start of the day's activities was the sounding of "Taps" by a volunteer band of musicians hastily assembled when word came of the closing of the Olds business. Each musician was playing his Olds instrument, of course, in the sentimental salute.

The F.E. Olds & Son Co., moved to Fullerton from Los Angeles in 1954.

The company was founded in 1928 in Los Angeles by Frank E. Olds and his son Reginald. The company was operated by the son following the death of the father. The son retired in 1963 because of health problems and died four years ago.

At its peak in 1974, Olds employed some 400 workers but only 200 a year later, Agard said.

Many changes were involved in the diminishing operation of the company which had, at one time, claimed production needs that used more than one-third of the year's market for brass.

In 1948, Chicago Musical Tasi ment Co. brought a majority of the stock and Olds became a subsidiary __ of Chicago. In 1954, Chicago acquired the remainder of the stock and Olds became a wholly owned subsidiary. During the 1960s, Olds sales and marketing control was moved-to-Chicago and Olds remained as a manufacturer only, Agard

Chicago Music Instrument Co. was purchased in 1973 by the New York conglomerate, Norlin Corp., which changed the name of Chicago to

During the past year, four serious negotiations had been conducted to sell F.E. Olds & Son as a going business, but all were unsuccessful.

The machines and men who created the musical instruments have gone or are going. Soon the building and its seven and one-half acres of land will be under new ownership

But the music lingers on. Treasured olds instruments are being played by many musicians everywhere, despite the invasion on the market of foreign, cheaper brands, it was indicated by visitors at the Wednesday auction when the volunteer band took an improvised

As for the last employee, Agard is remaining faithfully on the job he has held for 28 years until the final piece of equipment is moved out and the building readied for its new owner. That will be about Dec. 1.

Then I'll be out looking for employment - I'm not rich and I'm not ready for retirement, I hope to continue living in Fullerton and drive to that job I hope I find."
